Also can we give one pc of each item or we have to send the full kit.	You can send the common items in one pack and indicate that they are for Lot 4 and Lot 5 plus the Razor for Male Pack and Sanitary pad for Female Pack
	28-11-2018	In other lots Item 6 to 10 we have to send one pack / pc or whole set .	fro Items 6 to 10 you can send one or two packs from each lot.
