# Ad 4) Announcements from the Chair and briefings in writing from committees, if any.

### • The reorganisation of HQ is underway

The Secretary General and EMT (i.e. Executive Management Team) have initiated phase 1 of DRC's reorganisation, in which HQ is the sole focus. Phase 2 will look at both country and regional levels. The latter will also be based on the new 2025 Strategy and an analysis of processes within DRC. The aim being to ensure an organisation that is efficient across the board, and which has the necessary economic latitude to ensure the organisation's operative presence and its development /innovation.

#### • Beirut, Lebanon – explosion

DRC's Country Director in Lebanon, Rickard Hartmann, has reported that all DRC staff members are safe following the devastating explosion in Beirut on 4 August.

The situation is being followed closely, and DRC has received DKK 2.8 m in funding from DANIDA with a view to providing humanitarian aid to the most vulnerable groups affected by the catastrophe resulting from the explosion.

In particular, DRC will be focusing on the protection of the most vulnerable groups through psychosocial first aid and acute economic grants to cover urgent lifesaving needs through collaboration with DRC's local partners in Beirut. Alongside this, a comprehensive assessment has been completed in the areas of the capital that were most affected by the blast. Here, the focus has been on providing economic contributions to the re-establishment of small shops.

As many are leaving Beirut, work is also being put into expanding the humanitarian assistance in existing programme areas (Beqaa, Akkar, and Tripoli).

Coupled with the existing economic crisis and the consequences of COVID-19, DRC will be focusing on alleviating the secondary significance that the explosion in Beirut will have for Lebanon's refugees and host community.

• ECHO (i.e. European Commission Humanitarian Aid ) Ex-Ante (i.e. Expected) - Approval of DRC continuing as a collaborator

DRC has achieved a total score of 9/10 and no individual score below 4/10, which is the minimum level. The auditors have therefore concluded that DRC is qualified to enter a partnership agreement with ECHO.

# Ad 5) AOB

The Chair, Agi Csonka, thanked Rasmus Larsen Lindblom for his huge involvement in, and contribution to, the activities of both the Executive Committee and the Audit Committee. While Rasmus was voted onto the Executive Committee in 2017, he has chosen to step down from the Executive Committee in connection with having moved on to a new job.
